- 1) During the last month, the **Events page has been updated** to remove events that had already passed and add new ones. A notable addition is the new Deaf Friends of Bill W. meeting for the deaf, which began recently. It is every Saturday afternoon at 2 pm at Christ Episcopal Church, 830 Romancoke Rd (Rt 8), Stevensville. Sign language interpreters will be available. Please spread the word. (A note here: It was requested to not use the term "hearing impaired" as this offends the deaf. So that was removed from the web site.)
- 2) A blast email was sent to let everyone know about the Talent Show coming up. The flyer was attached to provide all the details.
- 3) A new Where & When was posted for April 5, 2018. All changes were also made to the web version of the meetings pages. One note, the Alano Club in Chestertown moved a while back, and Sue R. had sent the new address. However, I usually only make changes to the web site version of the W&W AFTER I receive an update from Jim. R. This is so the two lists can stay as closely in sync as possible. So please let both Jim and I know when there are meeting changes or additions. As soon as Jim's hard copy Where & When is completed, I will then update the web site.
- 4) Intergroup's monthly meeting information was forwarded to the Webmaster for Maryland General Service web site at the request of Sue R. They have a separate page set up on their web site (www.marylandaa.org) for an Intergoup Calendar.
- 4) **Google Analytics** reports show that over the last month, 403 users visited our site. They initiated 675 sessions, each lasting just over two minutes. More hits come from Google Searches, but there are a growing number of people coming directly to our site, which means these are established users coming back to get current information. There were 499 hits for the meetings page and 426 for the home page. Also, the data show that 52% of the hits came from mobile devices (i.e., cell phones), 40% came from a desktop, and about 8% from a tablet. This month there were 80 hits for the Events page. It was interesting to note the heaviest usage occurs between 10 am to 8 pm.

Please be sure to **keep the committee aware** of events, changes to the Where & When, the slate of officers, Intergroup by-laws, and anything else related to AA that would be of interest. Website Committee members are myself, Rose R. and Jenn B.
